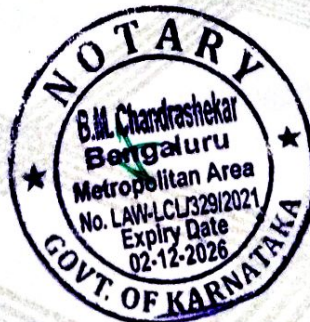

Conditions:

1. Change of school name after amendment of school name in school records.
2. The old name of the school along with its address shall be cancelled immediately after the execution of this order.
3. Sub-section 1) The concerned field education officer as per the order of the Government shall issue an order regarding the changed name and address of the school and the management board of the school of the name changed issue an order containing the Karnataka Societies Registration Number, address, Name of the members of the registration body under the Karnataka education Act.
4. The name of the school should be changed only once from the point of view of the administration if a proposal for a change is submitted it will not be considered.
5. The management should not run the school under the name of the old school for any reason.
6. The newly renamed name shall prevail from the date of change of name of the school for the office affairs.
7. The District Education officer shall inform this office in writing as soon as the change takes effect regarding the running of the school under the new name.
8. Instruct the management to bring the change of name to the public notice in the local newspapers and inform the public about the change of name of the precious name school in the same publication.
9. The governing body shall update the affiliation for the changed school name.
