

1.	The total number of section of Bal Vatika shall be restricted 3 (1 in each Bal Vatika 1,2,3).The total number of sections from classes 1 to 10 shall be restricted to 12.The optimum number of the students shall be restricted to 40 in each section.Any further increase of section shall require prior approval of the board subject to compliance with affiliation bye laws and availability of 500sq.ft dimensions
2	Form A,B,C of the Building Safety Certificate uploaded in mandatory public disclosure on school's website.The school should submit the same on SARAS portal.
3	Renewed Fire NOC / Fire Safety certificate dated: 20.11.2023 updated on mandatory public disclosure should be submitted on the SARAS Portal
4	Safety Measure like Fire Extinguisher is not available in Composite Science lab.Curtains have been seen in the lab which is Fire Hazard.This school should remove the curtain and install Fire Extinguisher in the lab and submit the compliance with videography within three months on SARAS portal.



5	Class room Desk are placed in the Math Lab. The School should upgrade the Math Lab with proper demonstration table and Stools appropriate for conduct of practical in the lab. The school should also upgrade the stock with more learning aids, Kits and manipulating material and submit the compliance with videography within three months on SARAS portal.
6	The school is required to increase the variety of Genre of Library books like fiction, non-fiction, autobiography, encyclopedia, self help books, 6 Newspaper and 10 magazine should be subscribed as per SOP issued and submit the compliance with videography within three months on SARAS portal.
7	The School should make provision for ramp or lift to access the upper floor CWSN students as per RPWD Act and Board guidelines. The school should and submit the compliance with videography within three months on SARAS portal.
8	Regular Cubicles have been converted in to CWSN toilets, hence are too small and narrow for free movement of Wheel chair/walker. The school building is G+1, but only one CWSN toilet each for boys and Girls is seen. This school should construct the toilets, separately for boys and girls on every floor with sufficient space for easy movement of wheel chair as well as hand rail on both side of toilet sheet (Fixed and Moveable) and proper permanent signage on the cubicle indicating the floor number as per norms of RPWD at Act 2016 and Circular No.5 Dated 06.03.2023 and submit the compliance with videography within 3 months on SARAS portal
9	The school shall conduct training of its teachers with CoE Chennai within three months and submit the compliance of SARA portal.

Compliance of the above mentioned points shall be submitted within three months on the SARAS portal failure comply within the prescribed time shall invite financial penalty @ Rs.50000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/data/information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye-Laws-2018.
2. The school shall follow the RTE Act 2009, and instruction issued thereon by the CBSE/respective state/UT/Government from time to time. The school will also abide by the condition prescribed, if any, by the state Government concerned
3. The school shall apply online for extension of Affiliation along with the requisite fee and other documents as per rule 10.3 of Affiliation Bye laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines/ instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE website i.e., <http://cbseacademic.nic.in/> & <http://CBSE.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
